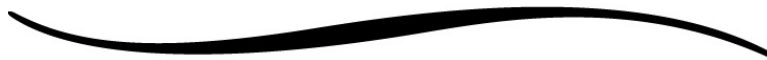

# *Application for Farm Building Assessment Review*

## **General Information**

### **Purpose**

The farm building assessment review initiative recognizes the economic pressures farming operations have been experiencing over the past number of years and provides economic or functional obsolescence allowances to structures that are no longer used for the purpose for which they were originally constructed.

### **Who is Eligible**

Owners of bona fide farm properties where there has been a change in use in the farm buildings.

### **General Guidelines**

Farm buildings that are:

- no longer used for the purpose for which they were originally constructed,
- converted to an alternate use, or
- vacated completely

may be eligible for an assessment adjustment.

### **How to Apply**

Complete the attached application form and return to Taxation and Property Records.
