- (D) LICENSE FEES CAN BE PAID BY CASH, CHEQUE OR MONEY ORDER MADE PAYABLE TO THE PROVINCIAL TREASURER [SECTION 9(3) AND SCHEDULE 6 OF THE *PEI FISHERIES ACT REGULATIONS*].
- (E) ALL INFORMATION MUST BE PROVIDED BEFORE THE ISSUANCE OF A LICENSE WILL BE CONSIDERED.
