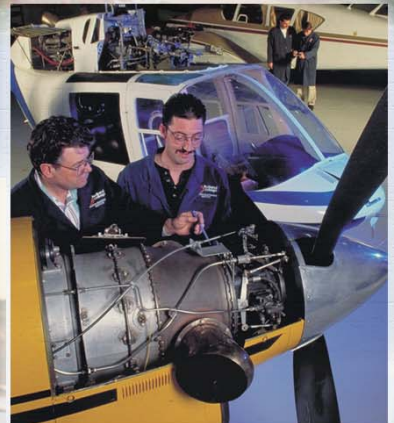

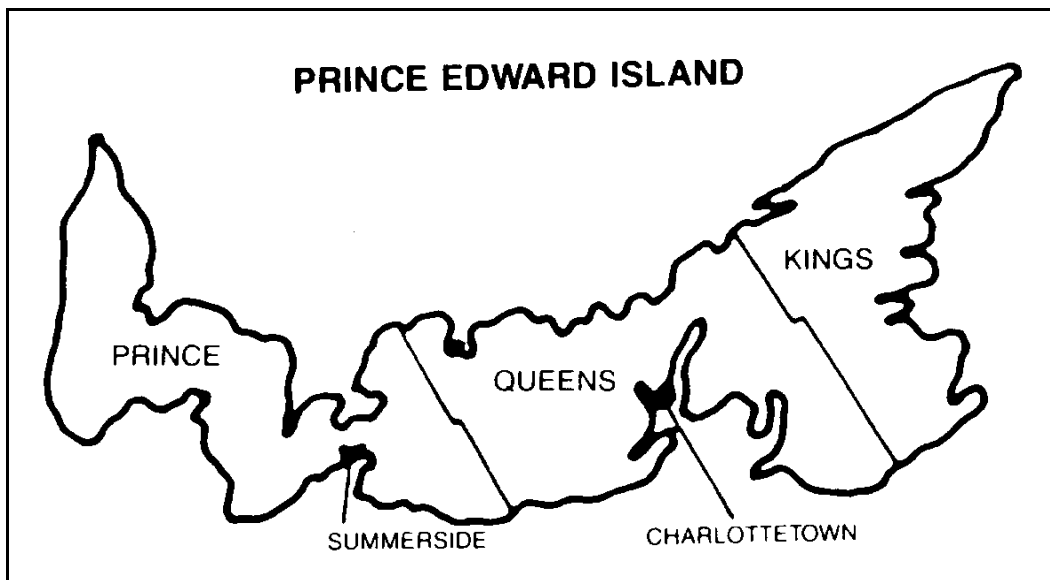

ECONOMIC REVIEW 2001

OVERVIEW

In 2001 the growth of the Prince Edward Island economy slowed from the pace set a year earlier. Preliminary estimates of constant dollar *Gross Domestic Product* (GDP) by Statistics Canada indicate that the provincial economy expanded by 0.1 per cent that year compared to 3 per cent in 2000. The national economy expanded by 1.5 per cent during the same period, down from 4.4 per cent in 2000. Despite this economic slowdown, the province experienced increased em-employment, a buoyant construction sector, and rising personal incomes.

Statistics Canada estimates of GDP indicate that leading growth sectors in the province were: information and cultural industries (up 6.6 per cent), public administration (up 3.2 per cent), and manufacturing (up 2.5 per cent). By contrast, the agricultural sector (down 28.6 per cent) experienced some economic difficulty as a result of near-drought conditions, which reduced crop yields, especially for potatoes.

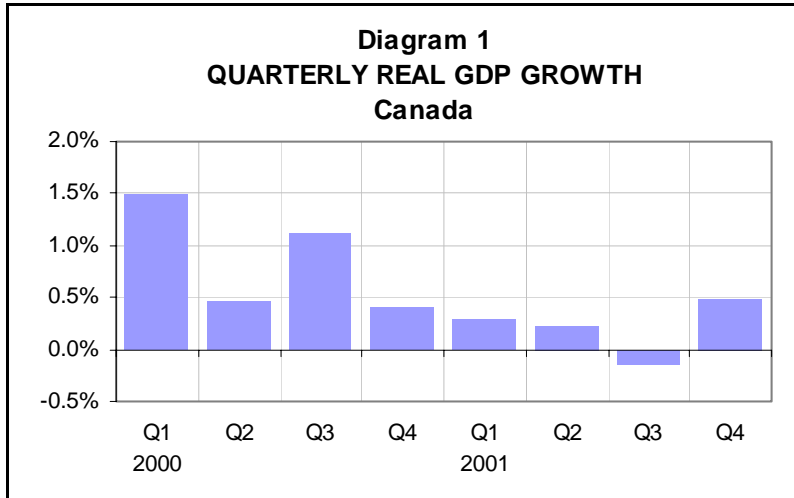
The general rise in consumer prices in 2001, as measured by the *All-Items Consumer Price Index* (CPI), for Prince Edward Island was at par with the national rate of 2.6 per cent. This compares with a 4.1 per cent increase in Island consumer prices in 2000. Following a sharp rise in 2000, energy prices started to decline in July 2001. The provincial energy index fell from 132.8 in January to 111.4 in December 2001, a decline of 16.1 per cent.

Island employment grew by 2.2 per cent during 2001, the third fastest growth rate in the country after Newfoundland and Alberta. Total employment averaged 65,900 people and the unem-employment rate dropped slightly from 12 per cent in 2000 to 11.9 per cent in 2001. These employment gains translated into total labour income growth of 4.5 per cent during 2001.

Following several years of sharp increases, the value of manufacturing shipments expanded by only 1.5 per cent in 2001, totalling \$1.2 billion. Food shipments increased by 3.3 per cent, while shipments of non-food items were down by 3.1 per cent in 2001.

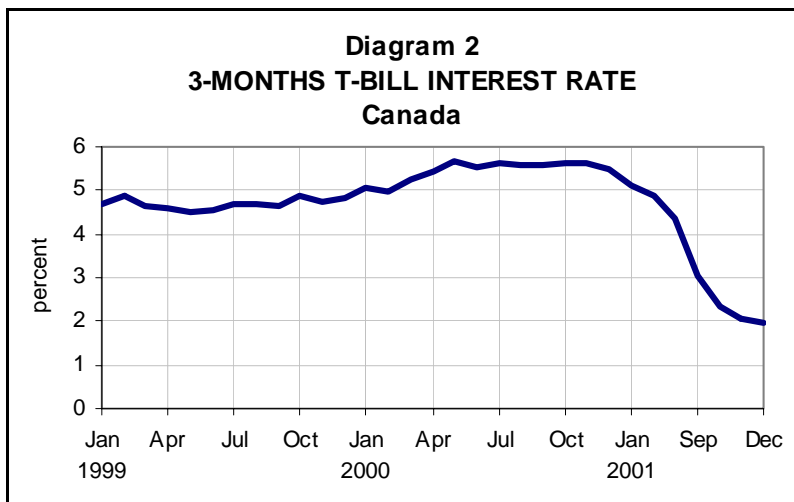
The economic performance of Prince Edward Island is discussed in further detail following a brief consideration of the national economy in 2001.

THE CANADIAN ECONOMY

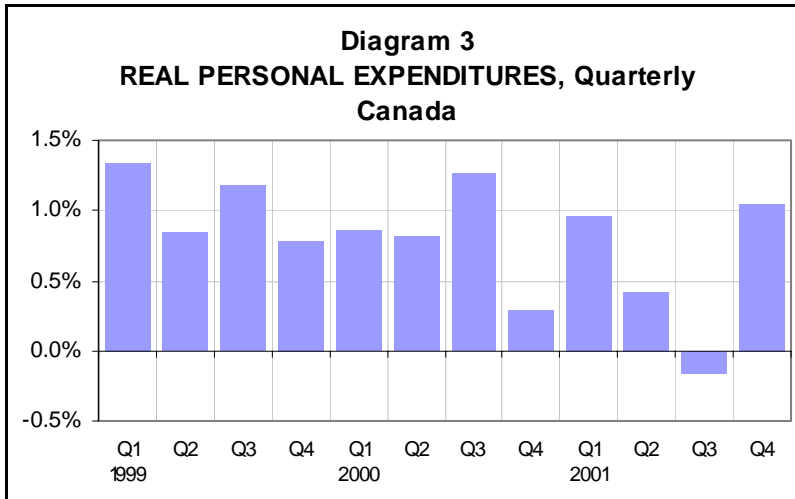
Canada's economy posted real GDP growth of 1.5 per cent, significantly below the 4.4 per cent reached in 2000. The expansion, measured in 1997 dollars, was led by consumer spending (up 2.5 per cent) followed by government expenditures (up 2.2 per cent). Gross fixed capital formation was up 1.4 per cent in 2001. The Government of Canada for the sixth consecutive year recorded a surplus of revenue over spending and debt servicing.

Diagram 1 indicates that, after strong growth in 2000, the national economic expansion weakened during the first half of 2001 and contracted in the third quarter, marking an end to 37 consecutive quarters of growth. Largely as a result of aggressive action to reduce interest rates, the economy rebounded in the fourth quarter. By the end of 2001

In response to the weakening economic situation in 2001 the Bank of Canada took action by lowering the Bank rate nine times during the year. As illustrated in Diagram 2, the interest rate on 3-Months Treasury Bills dropped steadily from 5.1 per cent in January to 1.95 per cent in December, averaging 3.7 per cent in 2001.

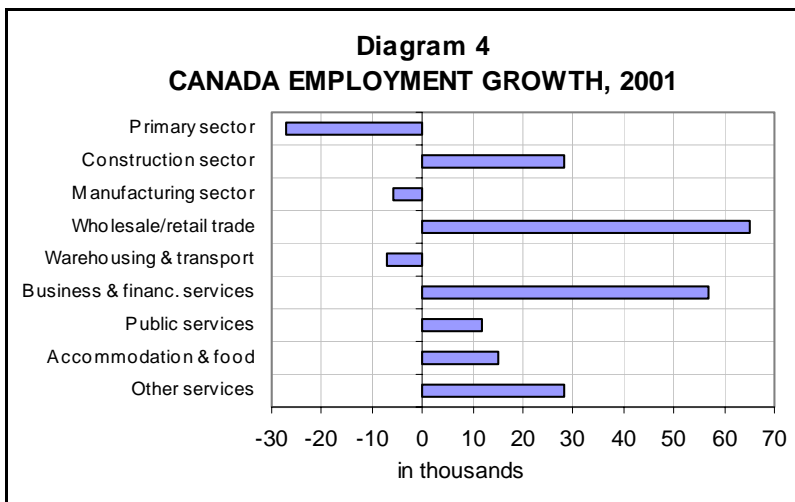

Falling interest rates helped bolster consumer spending during the first half of 2001, but consumer confidence fell during the third quarter as a result of the terrorist attacks in the United States on September 11 (see Diagram 3). Further action to lower interest rates caused consumer spending to rebound in the final quarter of 2001 re-sulting

in an annual growth rate of 2.6 per cent in real terms. Measured in current dollars, total personal expenditures on goods and services rose from \$593 billion in 2000 to \$620 billion in 2001, an increase of 4.5 per cent. Current dollar spending on durable goods increased by 3.5 per cent, while non-durables and services increased by 4.9 and 4.5 per cent, respectively.

As a result of lower energy costs, the average Canadian inflation rate in 2001, as measured by the *All-Items Consumer Price Index*, was 2.6 per cent, slightly lower than the 2.7 per cent recorded in 2000. The core inflation rate, i.e. the *All-Items Index* with the effects of energy and food prices removed, was 1.9 per cent in 2001.



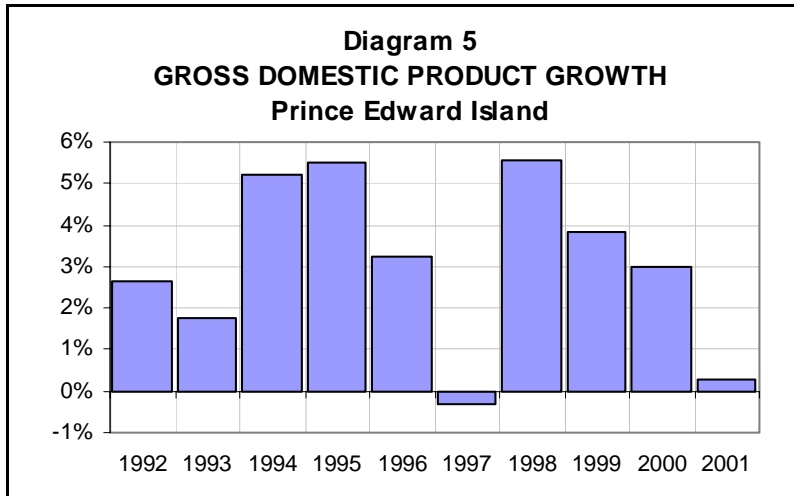

In 2001 national employment increased from 14.9 million in 2000 to 15.1 million in 2001, an increase of 1.1 per cent. Diagram 4 shows that most job creation occurred in the ser-vice-providing sector, espe-cially in the wholesale/retail trade and business and financial services. In the goods-produ-cing sector the loss of employ-

ment in the primary sector was largely offset by an increase in construction employment. Canada's unemployment rate rose to 7.2 per cent in 2001 from 6.8 per cent a year earlier.

THE PRINCE EDWARD ISLAND ECONOMY

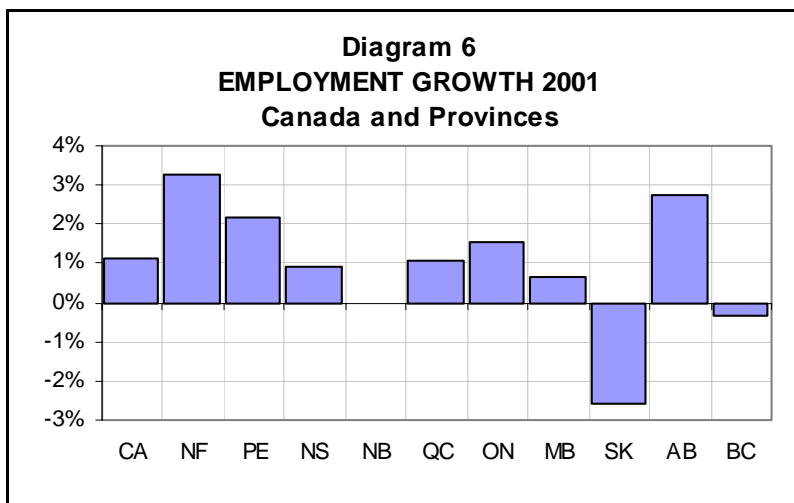
GROSS DOMESTIC PRODUCT

Following a strong expansion in the 1998-2000 period, real GDP growth slowed significantly in the Island economy in 2001, as illustrated in Diagram 5. Statistics Canada estimates that the economy expanded by only 0.1 per cent that year compared to 3 per cent a year earlier. Total GDP was valued at \$3.4 billion in current dollars in 2001.

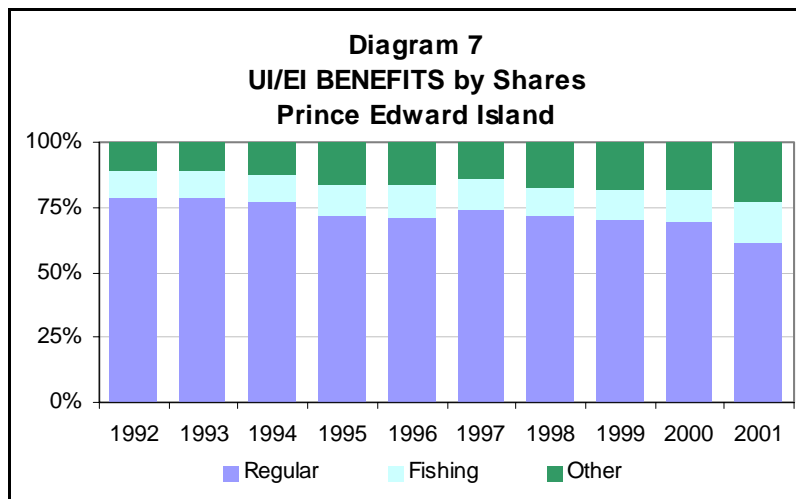
After leading the nation in employment growth in 2000, Prince Edward Island took third place in 2001 with an increase of 2.2 per cent (see Diagram 6). Employment increased from 64,500 in 2000 to a level of 65,900 in 2001. During the period 1992-2001, employment grew by 23 per cent, while the Island population grew by 5.8 per

cent and the labour force increased by 14 per cent. Thus, job growth outpaced both population and labour force growth in the 1990s.

The Island economy has seen a steady decline in its unemployment rate during the last ten years. Standing at 18.1 per cent in 1992, the annual unemployment rate averaged 11.9 per cent in 2001. This is the lowest annual average rate since 1981, when it stood at 11.3 per cent. During the year the unemployment rate bottomed out at 10.2 per cent in June, but increased to 12.5 per cent in December. The number of unemployed persons increased slightly from 8,800 persons in 2000 to 8,900 in 2001. The workforce, as measured by the participation rate, reached a record high of 67.6 per cent in 2001. This compares to a national rate of 66 per cent that year.

INCOME

Statistics Canada estimates that personal income for Prince Edward Island rose from \$3 billion in 2000 to \$3.1 billion in 2001, an increase of 3.6 per cent. The major contributors to this growth were labour income, which increased by 5.6 per cent, and federal government transfers to persons, up 5.4 per cent from 2000. Other sources of personal income in 2001 include investment income, up 1.4 per cent from 2000, and business income, which fell by 0.4 per cent. Net farm income dropped significantly as a result of the decline in potato receipts in 2001.

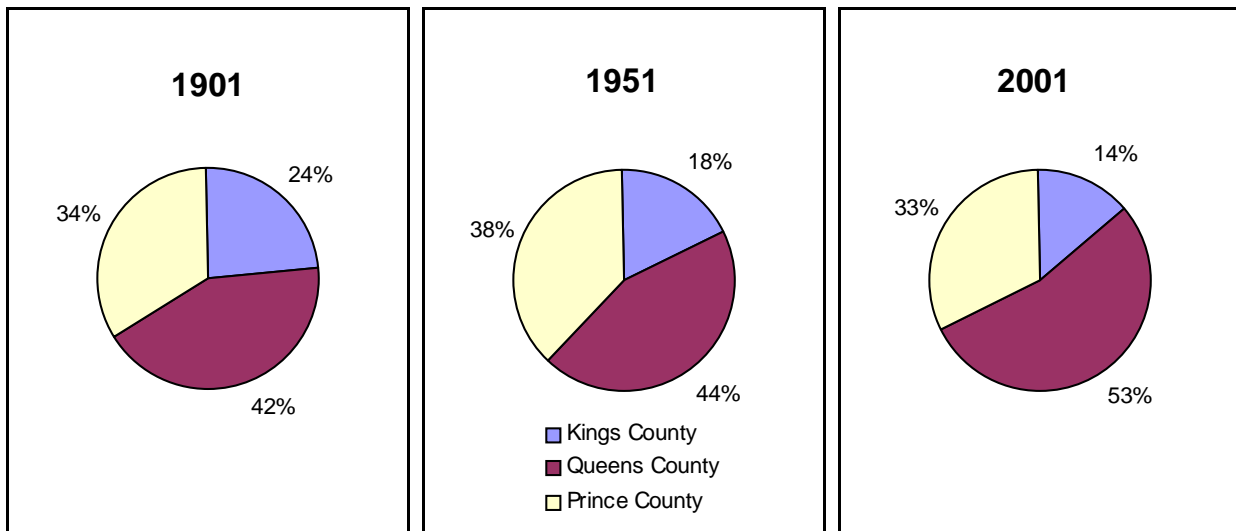
In 1999, federal transfer payments to persons made up twenty per cent of personal income. Thirty-three per cent of these transfers consisted of Old Age Security payments, while Employment Insurance (EI) benefits contributed 40 per cent to total transfers in that year. The latter increased from \$165 million in 2000 to \$189 million in 2001, an

increase of 14.1 per cent. This might be compared to the peak of \$216 million reached in 1993. As Diagram 7 shows, the distribution of these benefits has changed over the last ten years: in 1992, regular benefits accounted for 80 per cent of all UI/EI payments, while fishing and other benefits took up 10 per cent each. Ten years later, the share of regular benefits had dropped to 62 per cent, while the share of fishing benefits had risen to 15 per cent, and other payments, such as maternity/sickness benefits and training allowances, accounted for 23 per cent of total EI benefits. The average weekly benefit payment rose from \$247.59 in 1992 to \$270.61 in 2001.

POPULATION

The census count from the *2001 Census of Population* recorded 135,294 ⁽¹⁾ persons living on Prince Edward Island on May 15, 2001, an increase of 0.5 per cent from May 15, 1996. On that day 7.6 per cent of the national count lived in Atlantic Canada, down from 8.1 per cent in 1996. Within Atlantic Canada, Prince Edward Island was the only province with positive growth. Other provinces experiencing positive population growth during this period were Quebec, Ontario, Manitoba, Alberta and British Columbia. Between 1996 and 2001, the census counts of Nova Scotia and New Brunswick fell by 0.1 per cent and 1.2 per cent, respectively, while Newfoundland experienced a decline of 7 per cent.

Diagram 8 illustrates the change in Island population distribution by county during the last one hundred years. According to the 1901 Census, 24 per cent of the Island population lived in Kings County, 34 per cent lived in Prince County, while 42 per cent called Queens County home. Fifty years later, Kings County's share had declined to 18 per cent, while Prince and Queens Counties' shares increased to 38 and 44 per cent, respectively. In 2001, Kings County experienced a further decline to 14 per cent, while Prince County's share fell to 33 per cent. The population of Queens County increased to 53 per cent of the 2001 Census population.

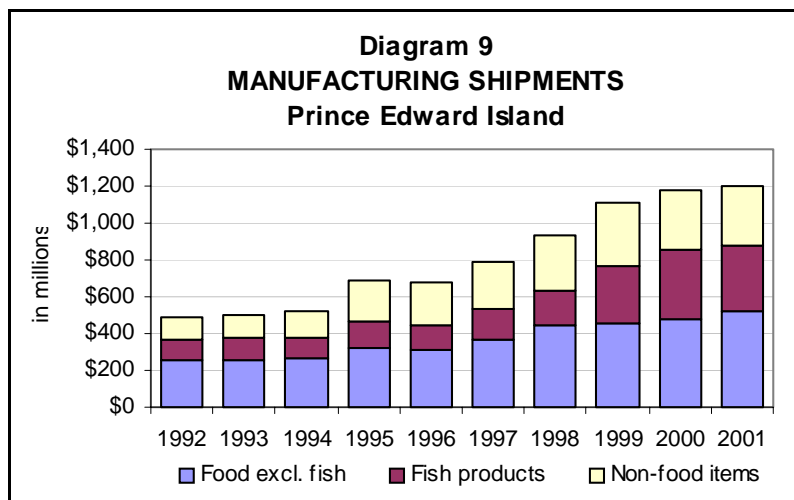
Statistics Canada estimated that the Island population reached 138,514 ⁽²⁾ on July 1, 2001, an increase of 449 persons or 0.3 per cent from 2000. Natural increases, i.e. total births minus total deaths, contributed 53 per cent to this change, while 47 per cent can be attributed to international and inter-provincial migration. During the last twenty-five years the Island population increased by 15.4 per cent, which compares to a national growth rate of 33.6 per cent.

INDUSTRIAL PROFILES

MANUFACTURING

The manufacturing sector is a growing component of the provincial economy. Between 1992 and 2001 the manufacturing component of GDP at factor cost in constant dollars outperformed all other sectors with a growth rate of 113 per cent. Total GDP at factor cost increased by 33 per cent during the same period. In 2001, the manufacturing sector contributed 10 per cent to

Island GDP and made up 43 per cent of the goods-producing sector.

After growing at an average annual rate of 12 per cent between 1992 and 2000, the total value of manufacturing shipments in 2001 rose by only 1.5 per cent. This drop was mainly the result of a reduction in the supply of potatoes resulting from exceptionally

dry growing conditions. Total manufacturing shipments in 2001 were valued at \$1.2 billion. Seventy-three per cent of this value, or \$882 million, was attributed to the Island food

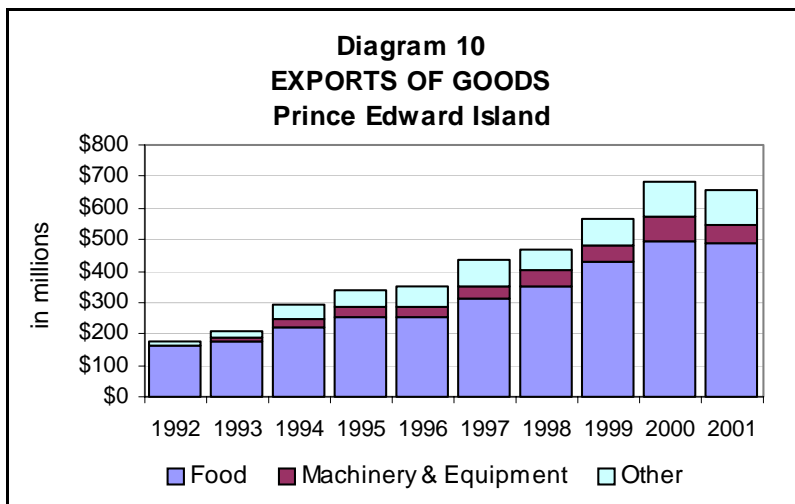
processing industry. Diagram 9 shows that, although food processing continues to play a major role in manufacturing, the importance of non-food production has increased over the last ten years.

In 2001 the manufacturing sector provided 10 per cent of all employment on Prince Edward Island, making it the second largest private sector employer after the trade sector. The number of manufacturing jobs fell from 6,500 in 2000 to 6,400 in 2001, a decrease of 2.3 per cent.

EXPORTS

The value of exported goods increased from \$175 million in 1992 to \$683 million in 2000, an annual average increase of 19 per cent. In contrast to this rapid growth in exports, the export value dropped 3.7 per cent to total \$658 million in 2001. The export value of fresh potatoes, one of the Island's main export products, dropped 56 per cent in 2001 as a result of the lingering effects of the potato wart crisis and the resulting export ban imposed by the United

States in 2000, which was relaxed in April 2001 and eliminated in August of that year.



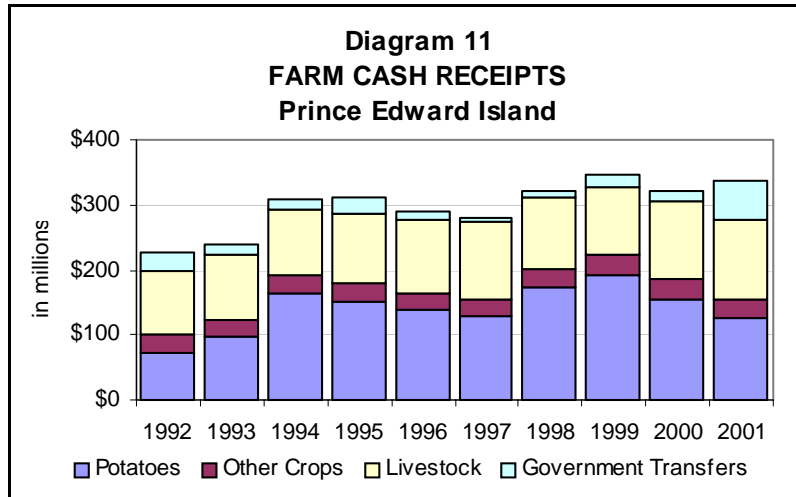

The sale of processed food products is a major component of Island exports, as can be seen in Diagram 10. In 1992 food products made up 92 per cent of total exports and were valued at \$160 million. In 2001 their value had risen to \$485

million, but their share had fallen to 74 per cent.

Other exports in 2001 included \$63 million in machinery and equipment, \$20 million in industrial goods, \$13 million in forestry products, and \$77 million in other Island-made products.

AGRICULTURE

As Diagram 11 illustrates, potato receipts were the most variable component of farm cash receipts during the last decade. Whereas in 1992 potato receipts made up 32 per cent of total farm cash receipts, by 1999 this share had peaked at 55 per cent. In 2001, this proportion fell to 37 per cent as potato receipts were valued at \$126 million. This decline of

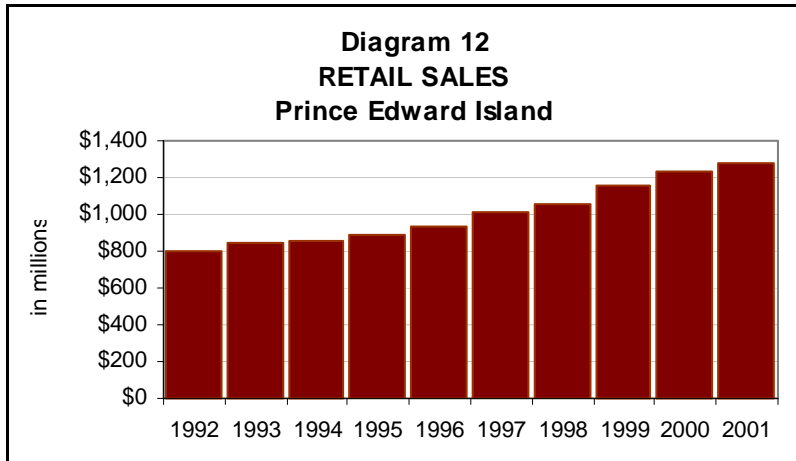
18.4 per cent from a year earlier was a result of U.S. trade restrictions and reduced yields due to near-drought conditions.

Cattle receipts reached \$25 million in 2001, down by 5.1 per cent from a year ago. On a volume basis, beef slaughtering was down by 12 per cent from 2000. Hog receipts reached an all-time high of \$33.5 million, up 13.6 per cent over 2000, surpassing the record set in 1996. Hog slaughtering in 2001 was up 7 per cent over last year. Total livestock receipts reached an all-time high of \$123.2 million, 3.9 per cent higher than last year, while dairy receipts increased by 2.9 per cent to \$52.5 million.

As a result of improved potato prices, increased government assistance to farmers, and higher livestock receipts, total farm cash receipts rose from \$321 million in 2000 to \$336 million in 2001, an increase of 4.7 per cent.

RETAIL TRADE

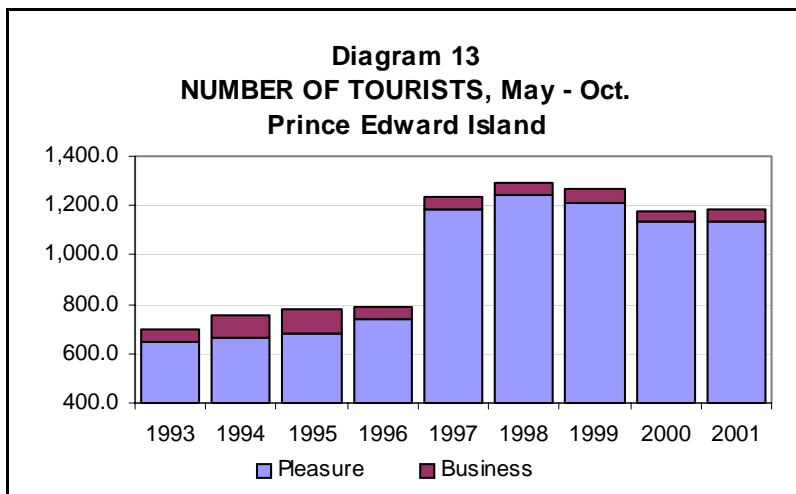
Provincial retail sales have steadily increased since 1992, as is illustrated in Diagram 12 (see next page), which displays annual sales. This trend continued into 2001, when, despite the weakening economy, over \$1.28 billion worth of goods were sold, an increase of 4.2 per cent from 2000. This compares to an increase in retail sales of 6.4 per cent in 2000. Department store sales were valued at \$392 million, while sales of new automobiles and commercial

vehicles totalled \$56 million and \$64 million, respectively. The wholesale/retail trade sector continues to be the largest private sector employer in the province with 10,000 people employed in 2001. Since 1992 employment in this sector has grown by more than 26 per cent.

TOURISM

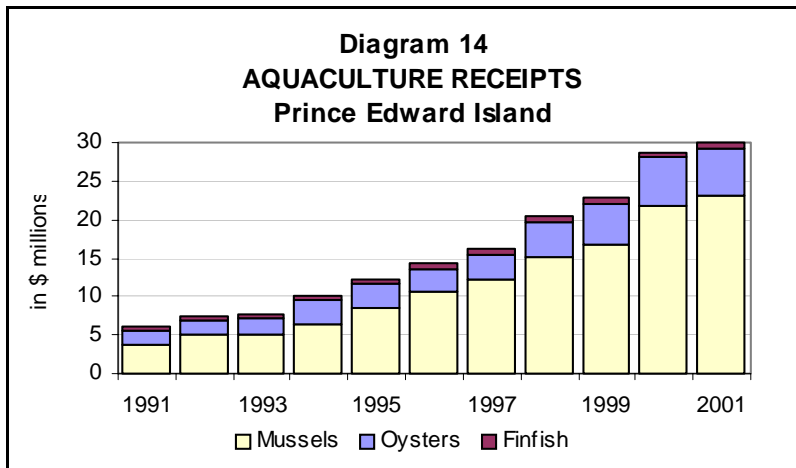
Prince Edward Island continues to be a premier tourist destination attracting a large number of visitors. As Diagram 13 indicates, the number of tourists who visited the Island since the opening of the Confederation Bridge in 1997 peaked in 1998 and has slightly fallen in subsequent years. During the 2001 season an estimated total of 1.1

million pleasure tourists and 45,600 business visitors spent a total of \$328 million while vacationing or conducting business on Prince Edward Island. This represents a slight increase of 0.5 per cent in visitor numbers and a 9 per cent increase in visitor expenditures compared to 2000.

In 2001, pleasure visitors accounted for about 93 per cent of all visits, with 76 per cent coming from Canada and 21 per cent originating in the United States. Ontario continued to provide the largest share of pleasure visitors in 2001 at 25 per cent, followed by Nova Scotia at 22 per cent and New Brunswick at 11 per cent. The number of pleasure visitors from the United States was 8.9 per cent lower in 2001 than in 2000.

FISHERIES

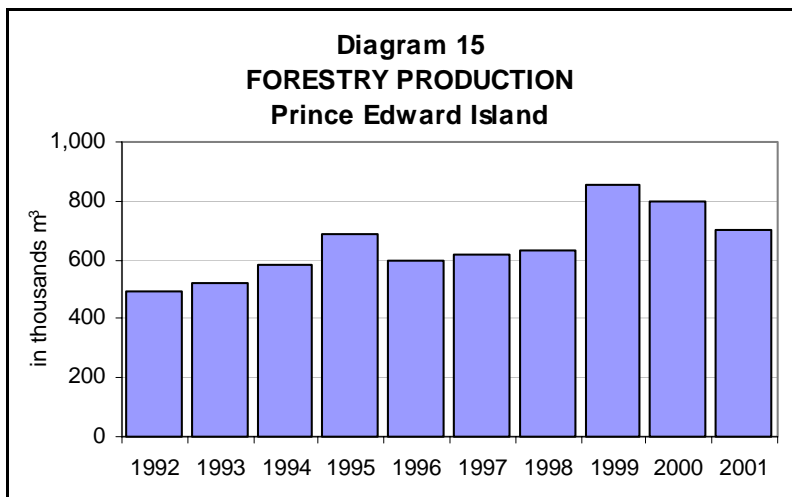
The value of fish landings in 2001 rose 11 per cent to \$161 million and was largely the result of higher lobster prices. The value of pelagic and estuarial catches was 2.8 per cent lower than in 2000, while the proceeds from molluscs and crustaceans other than lobster was at par with last year's value. The value of groundfish landings was 10 per cent lower. The 2001 lobster catch of 19 million pounds was slightly higher than a year earlier. Total revenue from lobster landings rose 18 per cent in 2001 to an all-time record value of \$103.9 million as a result of strong prices.

As shown in Diagram 14, aquaculture is playing an increasingly important role in the provincial fishing industry. In 1991 its share of total fisheries was 9.4 per cent and valued at \$6.6 million. By 2001, its share had doubled to 18 per cent and the value had risen to \$30 million.

FORESTRY

Diagram 15 shows that Island forestry production peaked in 1999 when it reached 854,000 cubic metres. After closing for a few months in 2000 to upgrade its facilities, the Island's largest lumber mill temporarily ceased operating again in 2001, this time as a result of low lumber prices and uncertainty over the softwood lumber dispute with the United States.

The volume of primary forest products was down by 11.5 per cent, from 795,668 cubic metres in 2000 to 703,572 cubic metres in 2001. Wood industry shipments were valued at \$52.6 million, down 4.1 per cent from 2000.

CONSTRUCTION AND INVESTMENT

The construction sector on Prince Edward Island expanded in 2001 on the basis of vigorous growth in non-residential building. The total value of building permits increased by 120 per cent over the previous year, totalling \$217 million in 2001. The number of housing starts fell

from 710 in 2000 to 675 in 2001.

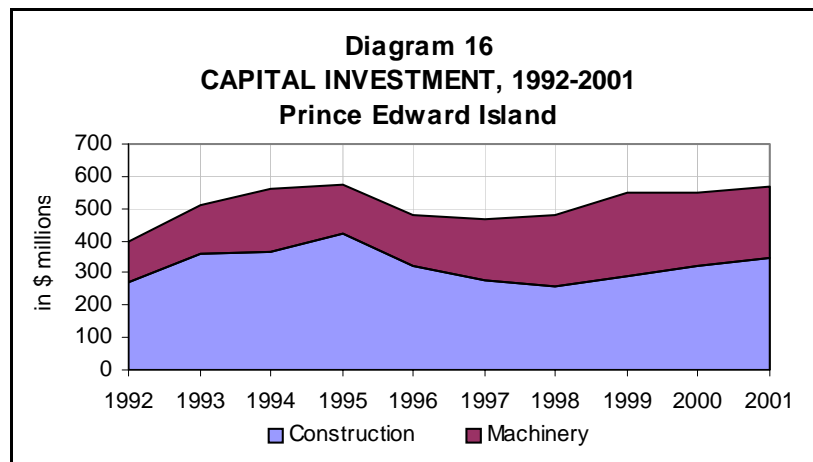


Diagram 16 shows the rising trend in construction on Prince Edward Island since 1998. Total preliminary actual investment amounted to \$566 million in 2001, up 3 per cent from 2000. This increase was principally the result of increased

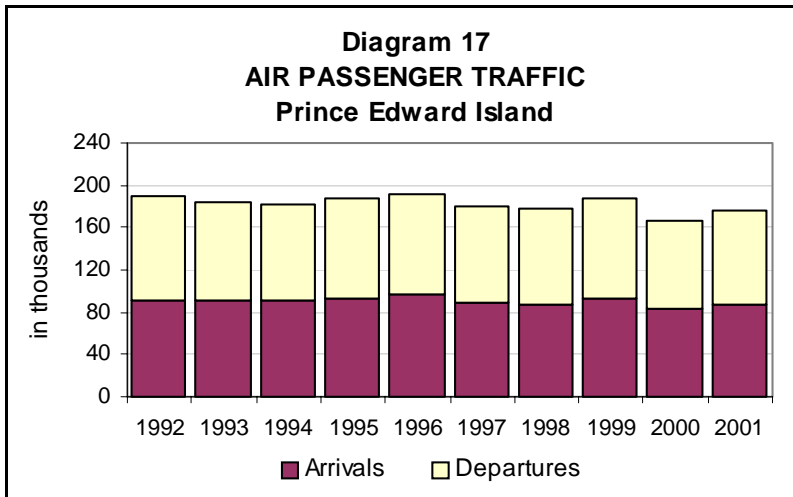
investment in the education, health and social services, and manufacturing sectors. Preliminary statistics indicate a drop in capital spending in retail trade, public administration and accommodations in 2001. Total private investments in 2001 were \$268.2 million in construction and \$188.8 million in machinery and equipment, while total public investments totalled \$77 million in construction and \$32.1 million in machinery and equipment.

TRANSPORTATION

Prince Edward Island has several transportation links to the mainland: the Confederation Bridge; *Northumberland Ferries* between Wood Islands, P.E.I. and Caribou, N.S.; the *Marine Atlantic* ferry service from Souris, P.E.I. to the Magdalen Islands; the Charlottetown Airport; and the ports of Charlottetown, Summerside, Souris and Georgetown. The principal source of

travellers to the Island is the privately-owned Confederation Bridge. According to estimates provided by the P.E.I. Department of Transportation and Public Works, a total of 1.5 million

vehicles crossed the Confederation Bridge in 2001, down 5.3 per cent from 2000.

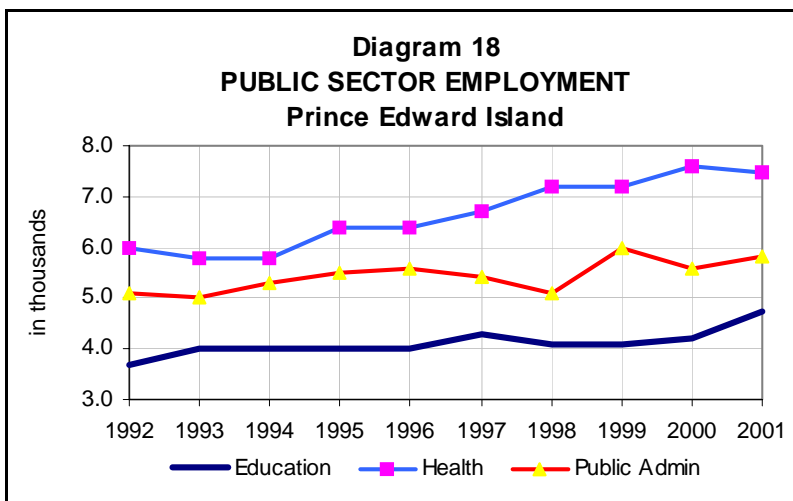

As Diagram 17 indicates, the number of passengers using the Charlottetown airport has remained relatively stable over the last ten years. In 2001 a total of 176,869 travellers passed through the airport, up 6 per cent from the previous year.

The ferry service between Prince Edward Island and the Magdalen Islands, P.Q., carried 11.5 per cent more passengers in 2001, while vehicle traffic was up by 12.8 per cent. The number of passengers taking the P.E.I. to Nova Scotia ferry service was up by 1.5 per cent, while the number of vehicles ferried across was up by 1.7 percent from 2000.

THE PUBLIC SERVICE SECTOR



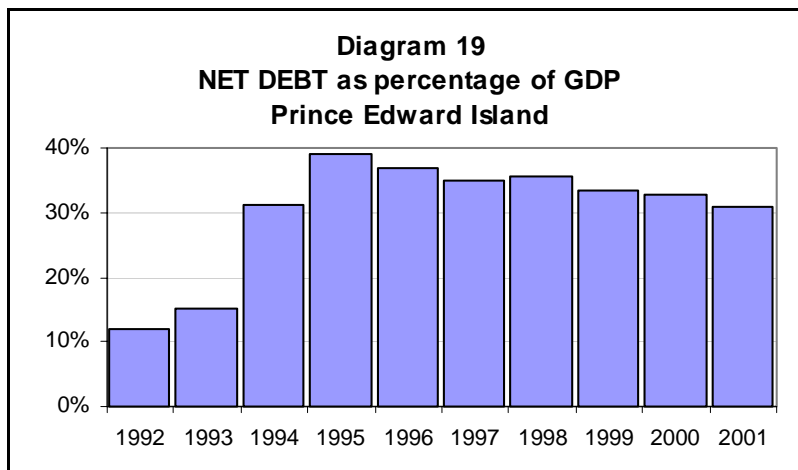

In 2001, the public service sector, i.e. federal/provincial/municipal public administration, educational services, and health and social services, made up 28.5 per cent of provincial GDP at factor cost and 27 per cent of total Island employment. Public sector GDP at factor cost rose from \$788 million in 2000 to \$805 million in 2001, an increase of 2 per cent. This compares to 4.3 per cent growth in 2000.

Diagram 18 shows employment growth in the public

sector between 1992 and 2001. During this period, the number of people working in the education sector increased, on average, by 3.8 per cent annually, while employment in the health and social services sector and public administration grew at an average annual rate of 3 and 2 per cent, respectively.

compared to \$5.4 million in FY 1999/00. As of 31 March, 2001, the net debt was \$1,036 million, up 1.1 per cent from 2000. Diagram 19 illustrates the decline in the Net Debt-to-GDP ratio since 1995.

In fiscal year (FY) 2000/01, total revenue received for the Province of Prince Edward Island was \$951.6 million, up 5.7 per cent from 1999/00. Total expenditures increased by 7.1 per cent to reach \$963.2 million. After pension adjustment and allowances for reclassified loan and capital lease, the deficit for FY 2000/01 was \$11.6 million,

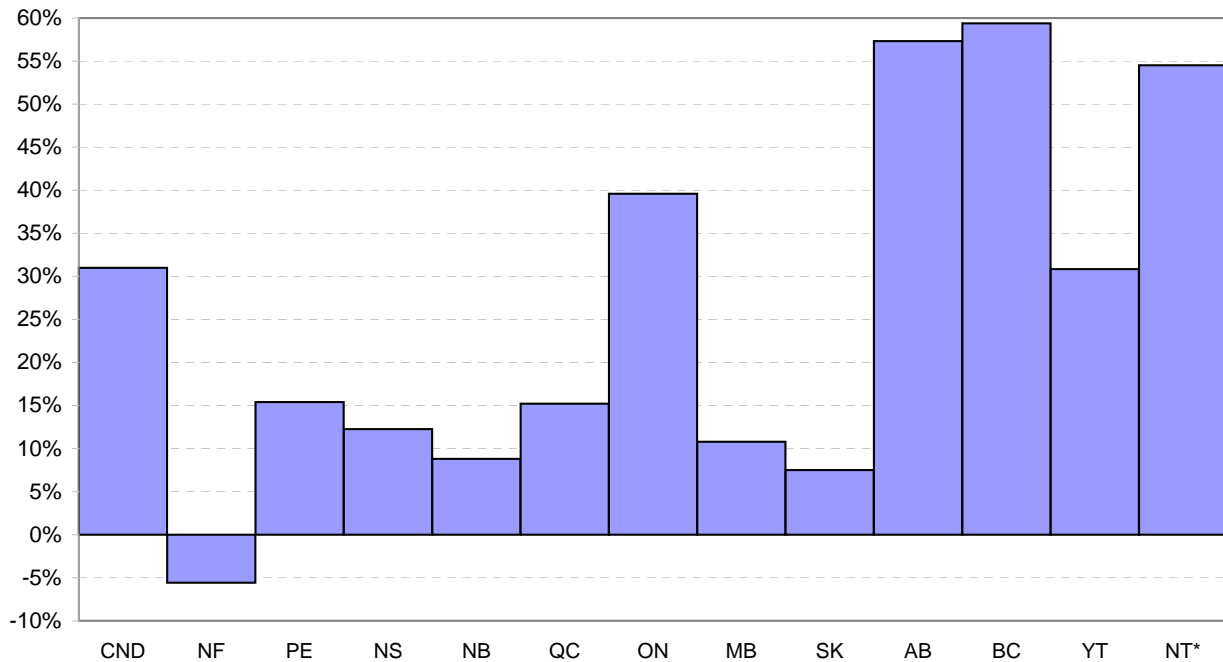

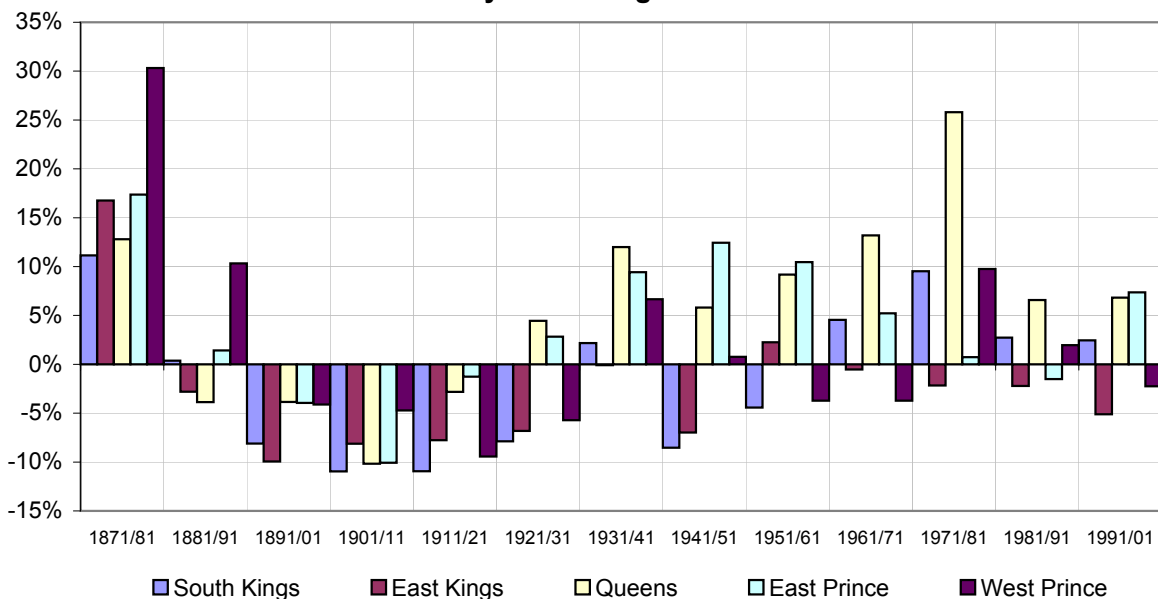

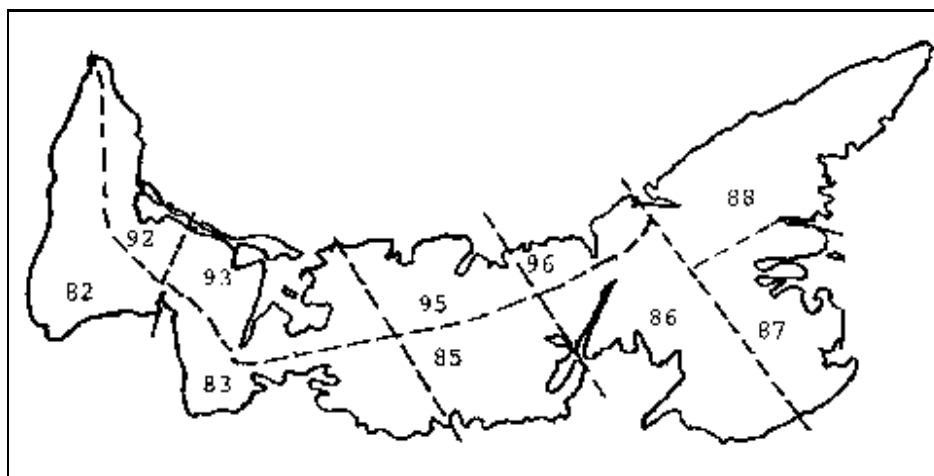
