Good Faith Deposit Agreement Form

Prince Govern	port of this undertaking, I have pledged a Good Faith Deposit of \$25,000 to be held by the Province of Edward Island for a period of one year after I am granted permanent resident status by the nment of Canada. The deposit is fully refundable (without interest), provided that I am able to provide ace satisfactory to the Province of Prince Edward Island that the conditions precedent for refund have met.
Condit	ions Precedent to Refund of the Good Faith Deposit Pledged by an Immigrant Partner
1.	That the Immigrant Partner is active in the investee company as a Director or as a Senior Manager at the "O" level of the National Occupational Code; and
2.	That the Immigrant Partner and his/her family have resided and maintained a residence in Prince Edward Island for a minimum period of one (1) year after receiving permanent resident status.
execut	nce that the condition precedent cited under (1.) has been met will be a declaration to this effect ted by the Chair of the Board of Directors signing together with the Chief Executive Officer on behalf of vestee company, and the Immigrant Partner.
a visit rental	nce that the condition precedent under (2.) has been met may include, but is not necessarily limited to, to establish the dwelling is owned/leased and occupied by the immigrant family; local employment; receipts; property tax records; utility bills; registration of any children at a local school or daycare community or other third party corroboration, personal Canadian income tax return and notice of sment.
Condit	ions Precedent to the Refund of the Good Faith Deposit Pledged by an Immigrant Entrepreneur
1.	That the business established by the Immigrant Entrepreneur is fully operational selling goods and/or services at arm's length to unrelated third parties; and
2.	That the Immigrant Entrepreneur and his/her family have resided and maintained a residence in Prince Edward Island for a minimum period of one (1) year after receiving permanent resident status.

Evidence that the condition precedent cited under (1.) has been met may include, but is not necessarily limited to a pre-arranged visit to the business premises; an examination of the books and records of the enterprise; examination of financial statements independently audited/reviewed by a Chartered Accountant or a Certified General Accountant; examination of tax returns to the Canada Customs & Revenue Agency or the

Provincial Treasury; or other independent corroboration.

Evidence that the condition precedent under (2.) has been met may include, but is not necessarily limited to, a visit to establish the dwelling is owned/leased and occupied by the immigrant family; local employment; rental receipts; property tax records; utility bills; registration of any children at a local school or daycare facility; community or other third party corroboration.			
One year after obtaining permanent resident status, the Provincial Nominee must give written notice to the Province of Prince Edward Island that the conditions precedent to refund have been met.			
The Province will indicate, in writing, the documentation to be provided by the Provincial Nominee to establish that the conditions to refund have been met and will determine what other evidence, if any is required to refund the Good Faith Deposit without interest.
