3) Violence Against Women Prevention Grants, application deadline October 19

The Interministerial Women's Secretariat provides assistance to the provincial government to promote the legal, health, social and economic equality of women. In addition, the Secretariat works in partnership with community organizations to develop projects, programs and services that benefit women in Prince Edward Island.

Sexual violence, family violence and other forms of violence against women come at high social cost. The outcomes are apparent in our social, health and justice systems. Violence against women impacts PEI's economic development and workforce. It impacts education, whether a student is personally experiencing peer-to-peer violence at school or at home. The impacts range varying sectors of society and they are immediate and long term.

Victims and survivors of violence against women include women-identifying people across all economic circumstances, geographic locations, ages, abilities and racial and cultural backgrounds. Violence against women impacts our communities, both rural and urban. Whether directly or indirectly, violence against women affects all members of our society. And each community experiences violence against women in unique, specific ways.

As such, it is vital to focus on prevention measures. The *Violence Against Women Prevention Grant* will be administered through the Interministerial Women's Secretariat to fund projects whose focus is the prevention of violence against women in PEI.

FUNDING PROGRAM OBJECTIVES

The objective of the *Violence Against Women Prevention Grant* is to provide project funding to community organizations for innovative projects that will enhance awareness, education and action towards preventing violence against women in PEI.

ELIGIBILITY REQUIREMENTS

Incorporated non-profit organizations from PEI will be eligible for funding. Projects from individuals (that is, projects that are submitted by individuals and not on behalf of a non-profit organization) will not eligible. **As these are one-time only grants, projects that require multi-year funding will not be considered.** All groups must commit to signing a contract and adhering to the requirements of the contract (including stipulations regarding insurance, reporting, or other).

For details of eligible expenditures, assessment criteria and assessment process, and other requirements see the attached information sheet.

APPLICATION PROCESS

Proposals must be received by **October 19, 2018**, and must meet the eligibility requirements. Any proposals that do not meet the eligibility requirements will be immediately disqualified. All final funding decisions will be made by the Minister Responsible for the Status of Women. Successful applicants will be notified by the International Day of the Elimination of Violence Against Women (November 25, 2018).

When immigrant women in Canada experience violence in their intimate relationships, they must also bear a cultural burden because it is framed as a form of violence experienced differently by racialized communities. A framing that hides the systemic inequalities and gender power imbalances re-created and reinforced by immigration policies. As a result, rendering invisible the ways in which government policies systematically place some population groups at risk, increase women's vulnerability to abuse, and fail to provide services and supports to them. Understanding immigrant women's experiences and responses to intimate partner violence postmigration must be embedded in the structures that constrain their role and participation in migration pathways and processes. This Webinar aims to make that link.

As an experienced violence against women researcher in Sri Lanka and a new immigrant woman in Canada, Vathsala brings a deep understanding of South Asian women's vulnerability to violence in their home countries, the complexities surrounding their migration experiences, and the gaps in services and responses to addressing violence experienced by immigrant and refugee women in Canada.

6) PEI ACSW Purple Ribbon Campaign 2018: Time to step up. Be ready to prevent violence against women

This is the theme of the Advisory Council on the Status of Women's Purple Ribbon Campaign for 2018-19. The ASCW is extending its bystander theme with a message for everyone to be prepared and take responsibility (see this year's Purple Ribbon card image attached). Everyone can have a positive role and help to eliminate violence against women. While every gender experiences and perpetrates violence, women continue to be disproportionately victimized.

Over 17,000 purple ribbons and bookmarks will be distributed in communities across PEI beginning in November and into the spring of 2019. The Status of Women counts on volunteers to pin the ribbons to cards in preparation for distribution. Pick up a shoebox package and step up and end violence against women.

7) Canadian Femicide Observatory for Justice and Accountability 8 Month Update: 106 women and girls were killed in Canada as of August 31, 2018

HIGHLIGHTS

- The first eight months of 2018, 106 women and girls were killed in Canada, primarily by men. On average, this means that one woman or girl is killed every other day in this country, a consistent trend during the past four decades.
- There is increasing attention to the vulnerability of older women because of their growing representation in the population. Almost one-third of the femicide victims were aged 55 and older, supporting the recognized need for priority attention to this group of victims.
- Indigenous women and girls continue to be overrepresented as victims of femicide.
- Almost half of the femicide victims were killed in their homes. This means that women are at greatest risk where they should feel safest.
- Shooting was the most common method of killing where this information was documented.

One-third of identified accused were male partners of the victims. Three-quarters of
these accused were still in an intimate partner relationship with the victim and onequarter were in dating relationships. These underscore the importance of pending
Criminal Code changes to capture dating relationships and current legislation which
directs judges to treat intimacy as an aggravating factor at sentencing.
