Dr. Lori Haskell is a clinical psychologist in private practice in Toronto. She also has a status appointment as an assistant professor in psychiatry at the University of Toronto and is an academic research associate with the Centre for Research on Violence Against Women and Children.

She has been dedicated to the prevention, treatment and training on issues relating to violence against women and children for the past 30 years. Dr. Haskell has presented at workshops, conferences and professional meetings in Canada and internationally. She has written a book entitled *First Stage Trauma Treatment: A Guide for Therapists Working with Women*, in addition to several other publications.

In recent years she has presented to the Canadian judiciary, both nationally and provincially, on behalf of the National Judicial Institute in Ottawa. She has also provided expert evidence in a number of legal proceedings. Most recently, she testified at the Coroner's Inquest of the domestic homicide of Sunny Park, her son and parents.
