2) Collaborative Law Practice Public Event, May 15

Collaborative Practice PEI (CPPEI) will be holding a public event on May 15 from 5:00-6:30pm at the Culinary Institute, 4 Sydney Street, Charlottetown, PEI to introduce the organization and the collaborative approach to separation and divorce to the public. Collaborative Practice is a new option for separating or divorcing couples to resolve disputes respectfully and equitably without going to court. The goal of this approach is to help couples focus on their most important goals, especially children, throughout the separation or divorce process. The end result is a more efficient, targeted and productive way to resolve disputes.

Collaborative law is a relatively new form of dispute resolution, pioneered in the 1980s by Minneapolis family lawyer, Stuart Webb. Primarily used in divorce where children, property, or other matters are involved, it allows for resolving issues privately while minimizing conflict and the impact on families.
