(a) For registration of every deed of mortgage where the principal sum is less than \$10,000 \$77.25

(b) For registration of every deed of mortgage where the principal sum is \$10,000 or greater but less than \$20,000 \$103.00

(c) For registration of every deed of mortgage where the principal sum is \$20,000 or greater but less than \$50,000 ... \$154.55

(d) For registration of every deed of mortgage where the principal sum is \$50,000 or greater but less than \$100,000 ... \$231.80

(e) For registration of every deed of mortgage where the principal sum is \$100,000 or greater but less than \$150,000 . \$309.10

For all other documents requiring registration in the registry office, including every assignment of mortgage, release of mortgage, release of judgment lien, mechanics' lien, lease, option to purchase, power and letter of attorney and every writing relating to or affecting any interest in or title to land in the province\$77.25

CERTIFIED COPY

For every certified copy of any registered deed, document or mortgage\$25.75
