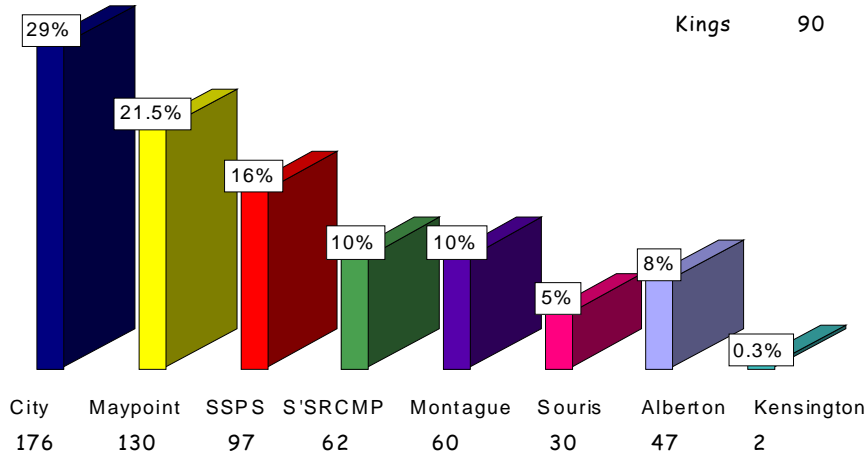

2002 - 604 Police DV files

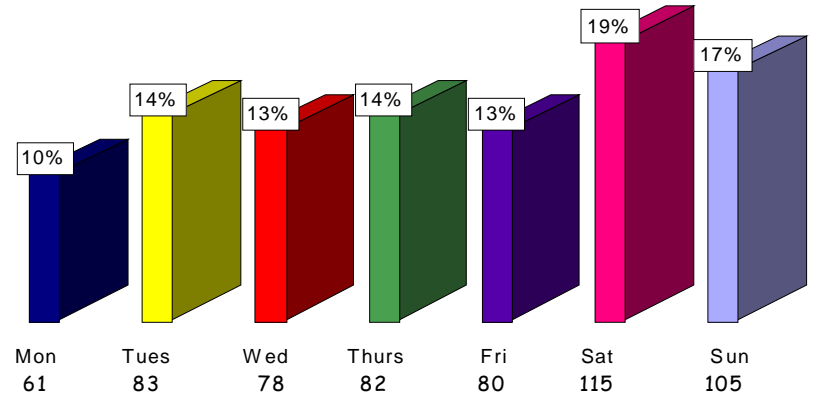

2002 - 604 Police DV files

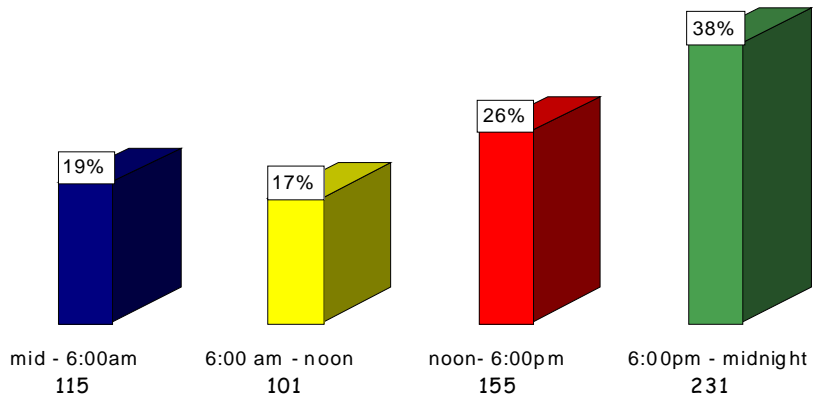

2002 - 604 Police DV files

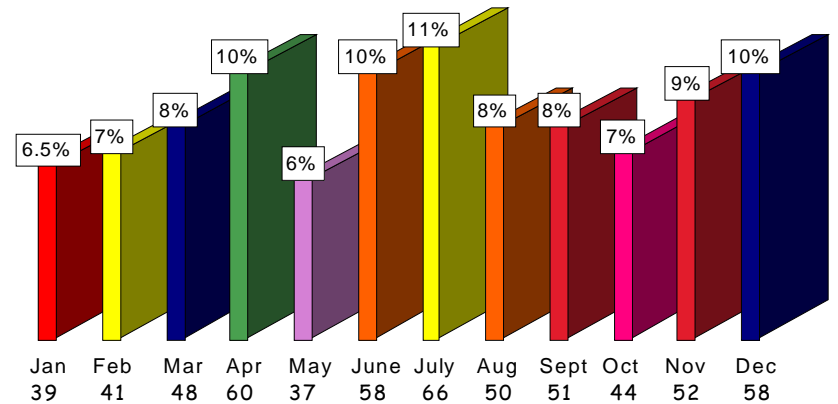

Complainant Source 2002 - 604 Police DV files

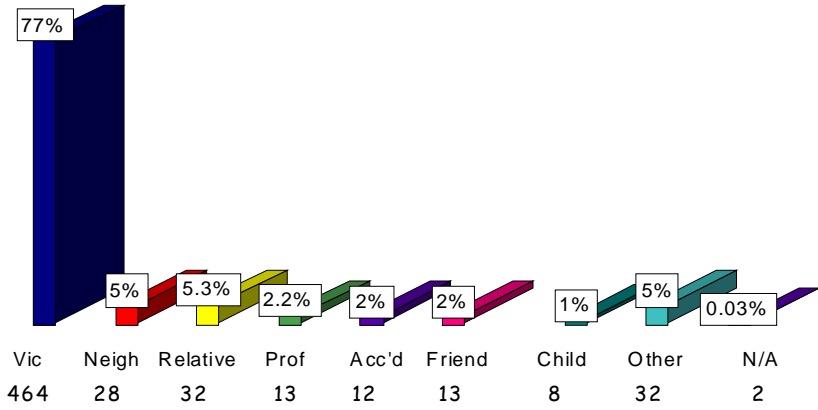

Victim Age

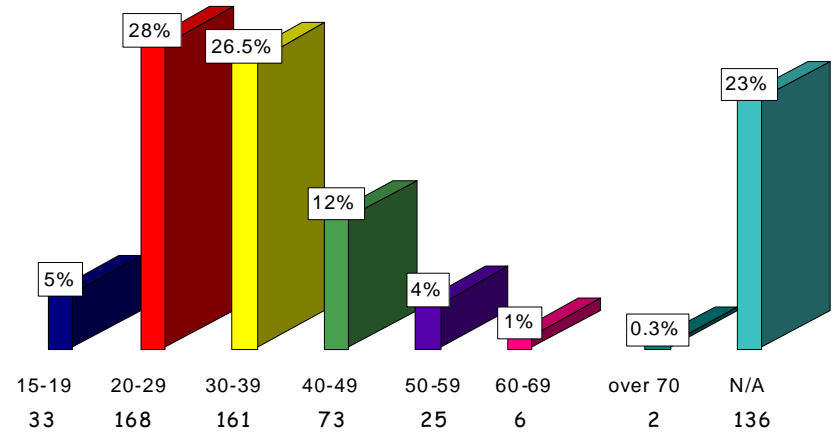

Victim Gender

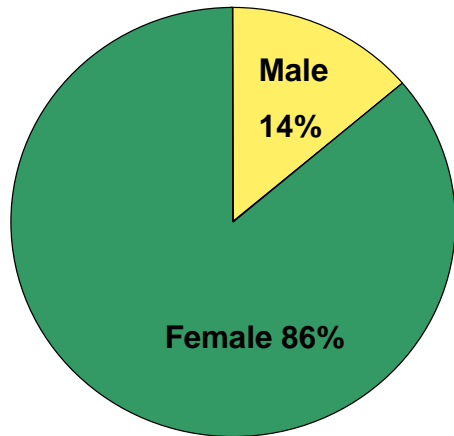

Offender Gender

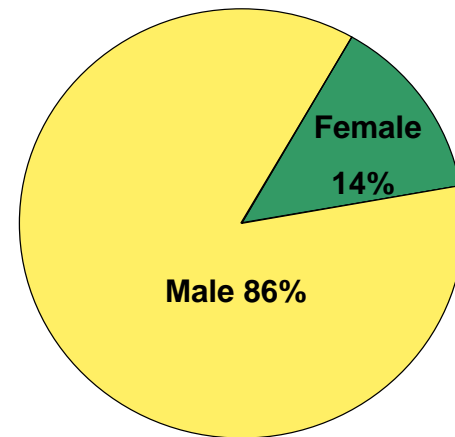

Offender Age

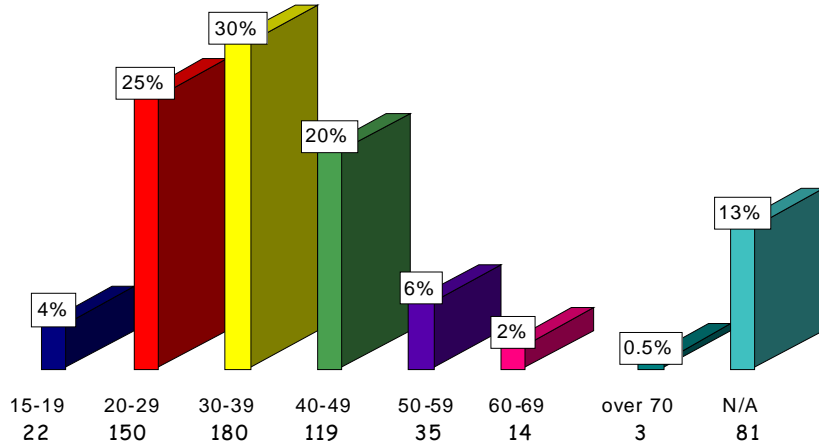

2002 - 604 Police DV files

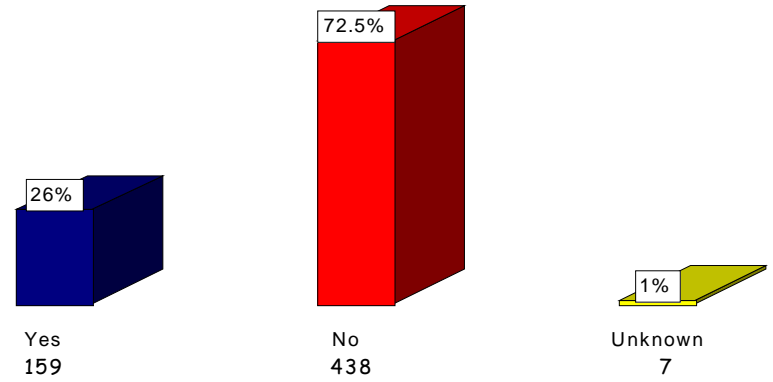

Relationship Status

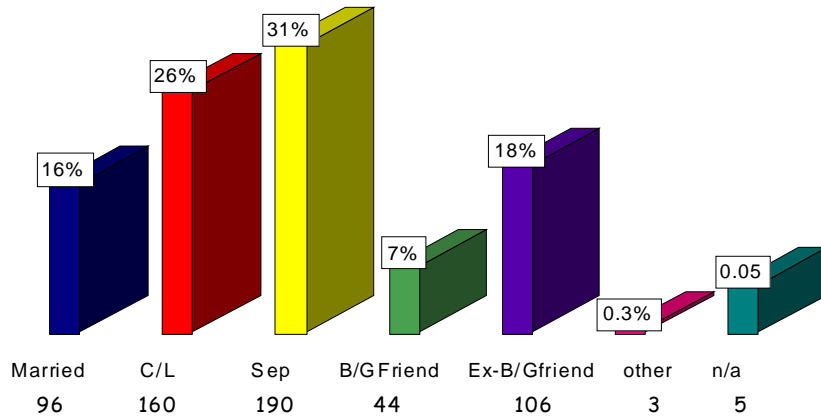

Injuries - Total 159 files

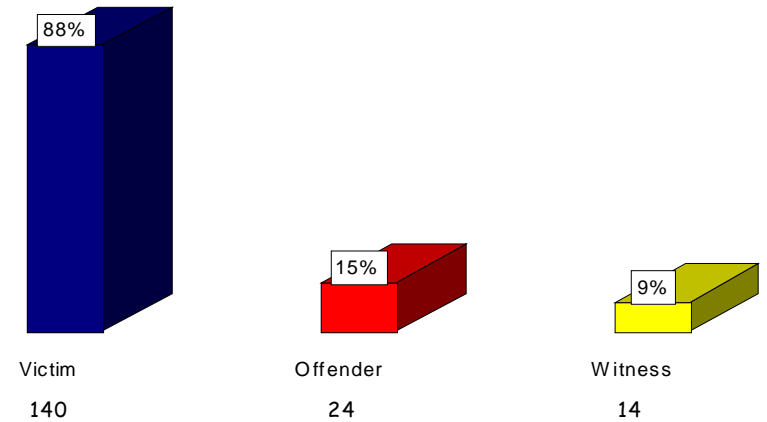

2002 - 159 DV Files with Injuries Reported

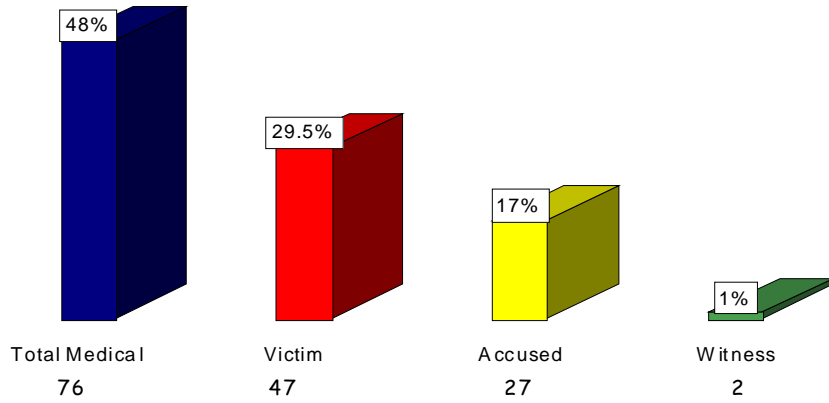

2002 - 604 Police DV files

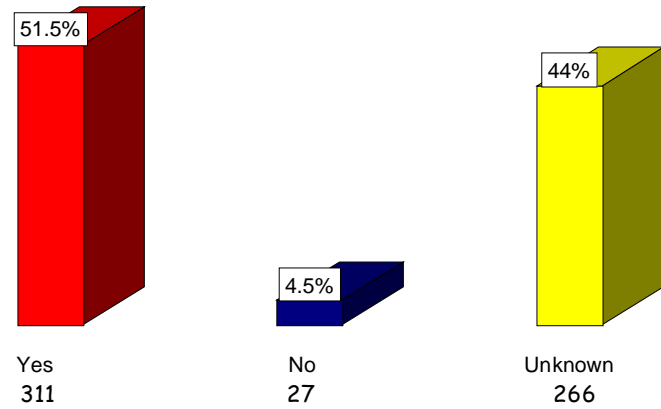

2002 - 604 Police DV files

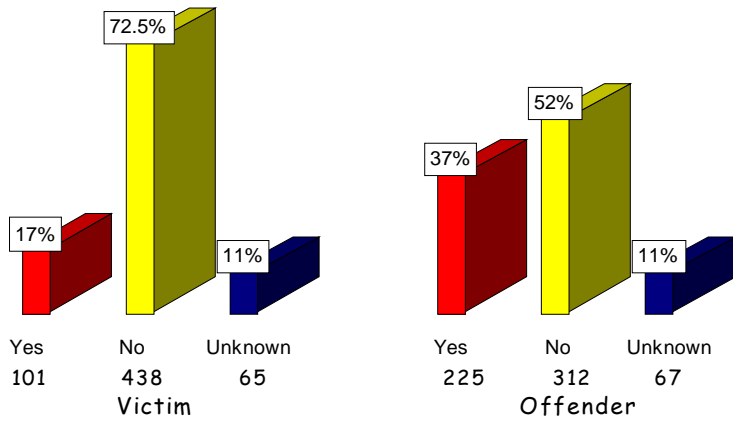

2002 - Total 604 DV Files - 40 Involving Weapons

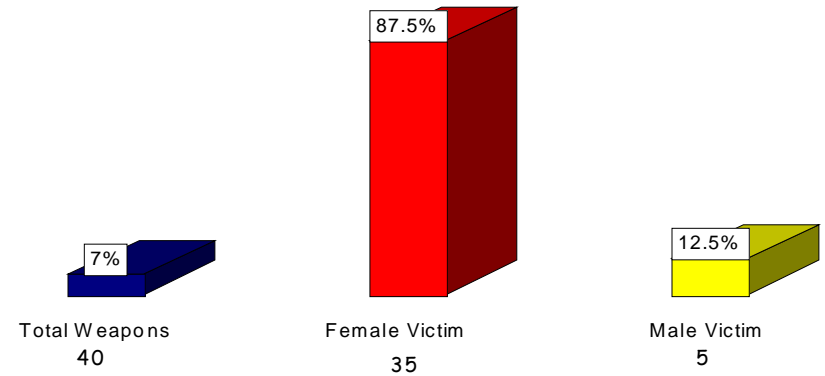

40 Files Involving Weapons

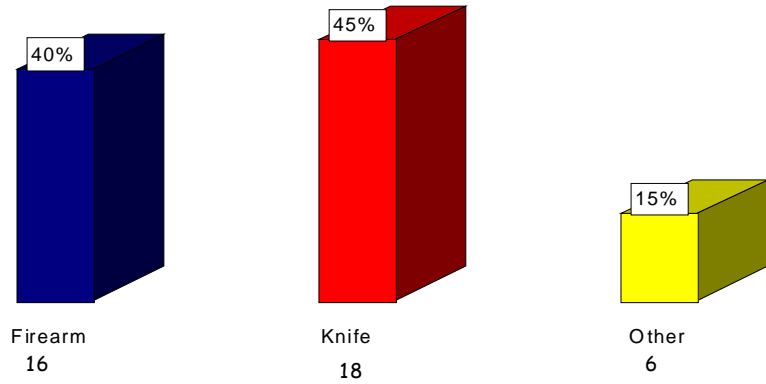

2002 - 604 Police DV files

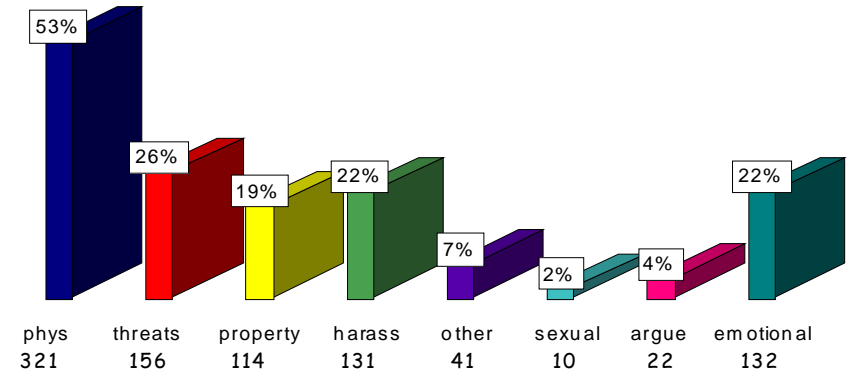

2002 - 604 Police DV files

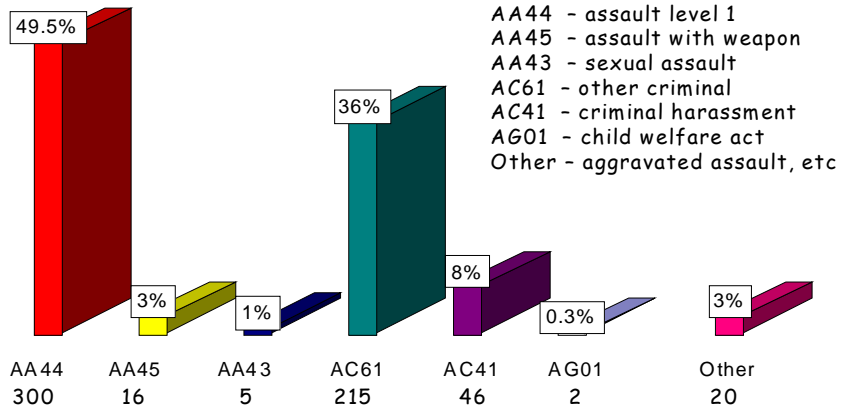

321 Physical Assault DV Files

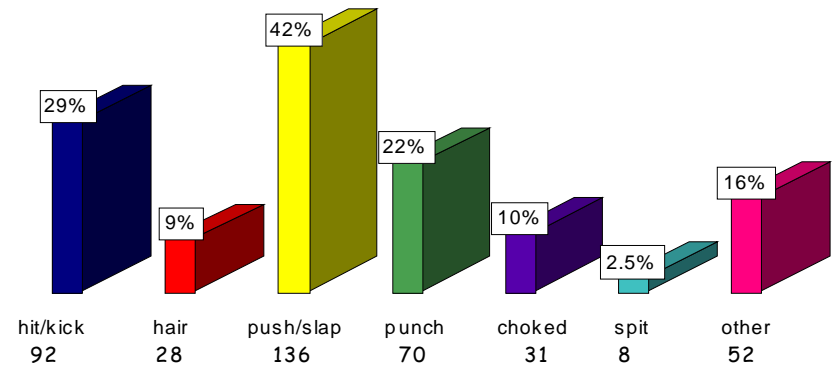


Figure 21 **Accused Detained**

 R_Police - released on conditions by a Police Officer

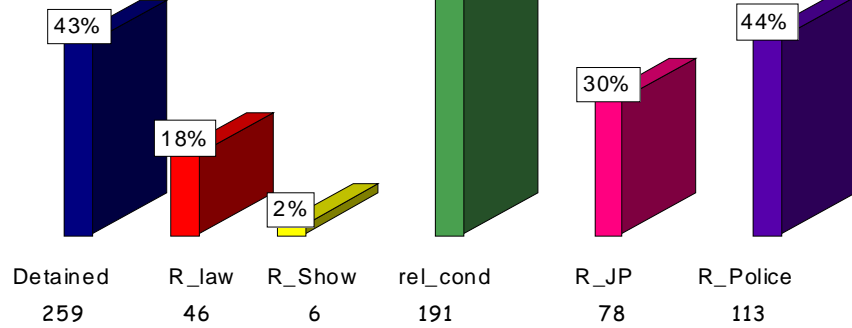

241 Confirmed Dispositions

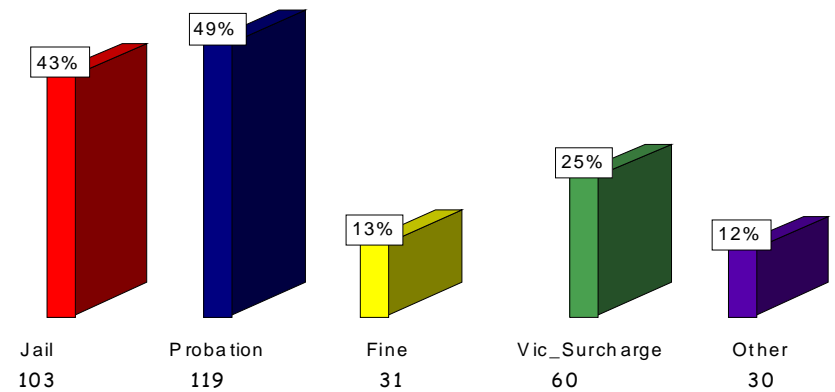

241 Confirmed Files

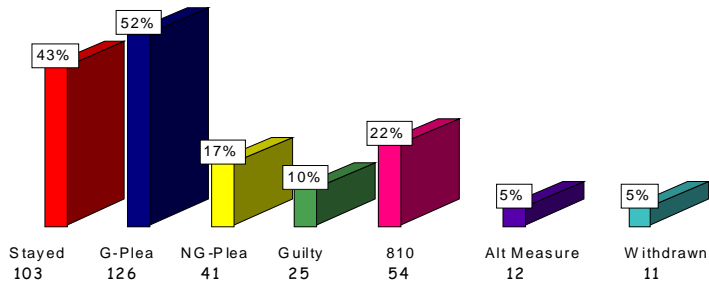

2002 - 604 Police DV Files

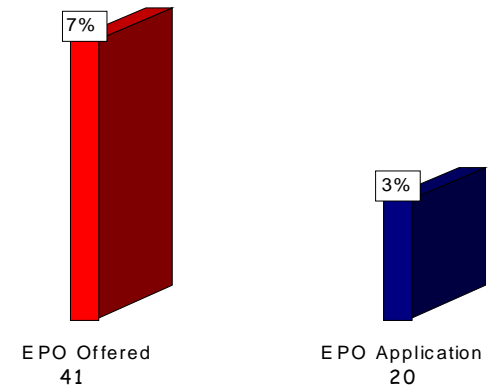

Application by Jurisdiction

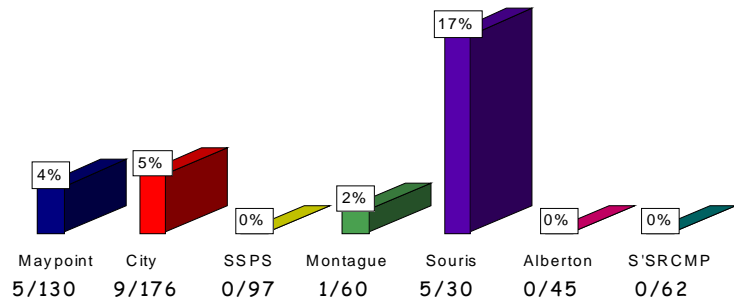


Figure 27 Police Referrals to Outside Agencies

291 Files with Referrals

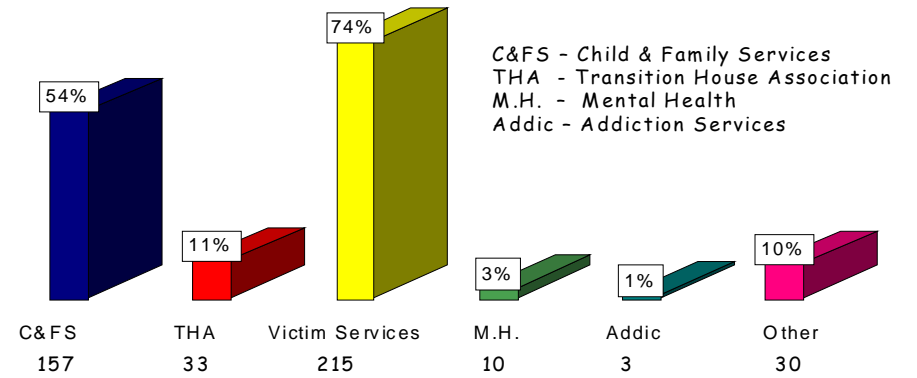


Figure 26 Police Referrals to Outside Agencies

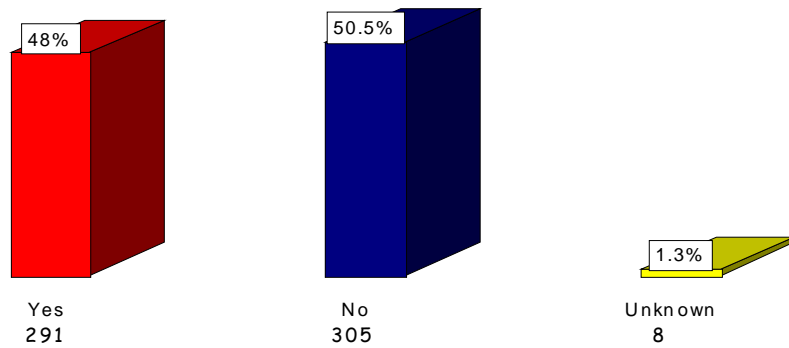

2002 - Total 158

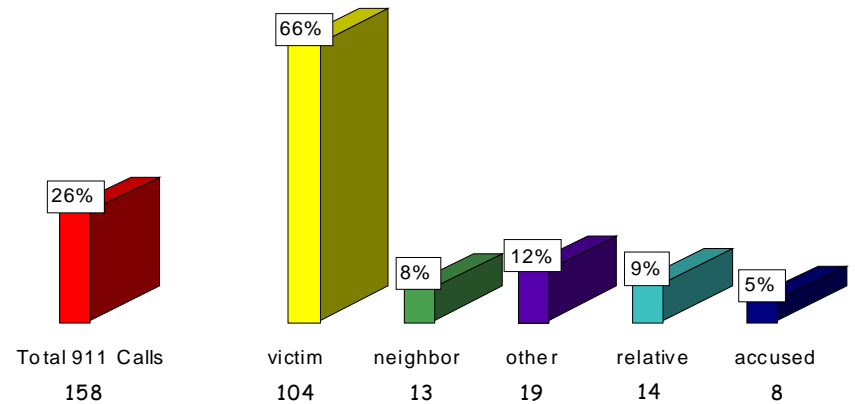

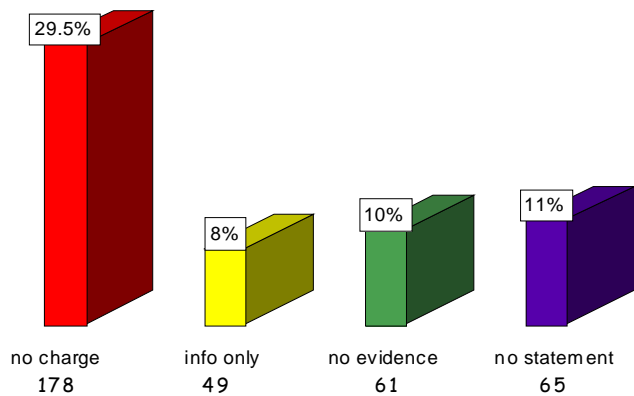

300 Police DV files involving Children

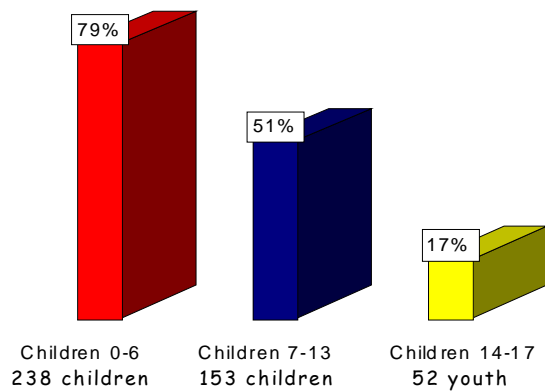
